This includes all liquid, solid and semisolid, materials which are not the primary products of public, private, industrial, commercial, mining, and agricultural operations.

Definition of Solid and Semi-Solid Waste affecting Environment

It is important to note that the definition of solid waste is not limited to wastes that are physically solid. Many solid wastes are liquid, semi-solid, or contained gaseous material. A solid waste is any material that is discarded by being: Abandoned: The term abandoned means thrown away. A material is abandoned if it is disposed of, burned, incinerated, or sham recycled.

Criteria for the Definition of Solid Waste and Solid and ...

(1) A solid waste is any discarded material that is not excluded under § 261.4(a) or that is not excluded by a variance granted under §§ 260.30 and 260.31 or that is not excluded by a non-waste determination under §§ 260.30 and 260.34. (2) (i) A discarded material is any material which is: (A) Abandoned, as explained in paragraph (b) of this section; or

The 2018 Definition of Solid Waste (DSW) rule went into effect immediately in states, territories, and tribes that are not Resource Conservation and Recovery Act (RCRA)-authorized, including Iowa and Alaska. State adoption of the 2018 DSW final rule is strongly encouraged, and some parts of the rule, including the definition of legitimate recycling found at title 40 of the Code of Federal Regulations (CFR) in section 260.43, are mandatory and will eventually be adopted by all the states.
